We Were Created

1. God created man in his image; in the divine image he created him; male and female he created them. God looked at everything he had made, and he found it very good.

In the beginning was the Word; the Word was in God's presence, and the Word was God. He was present to God in the beginning. Through him all things came into being, and apart from him nothing came to be. Whatever came to be in him, found life, life for the light of men. The light shines on in darkness, a darkness that did not overcome it.

- 2. I am, a living breathing soul created by a Supreme Being. The Creator gave me unalienable rights that cannot be transferred to another or taken away. These rights belong to me because I am.
- 3. The Right to Life, Liberty and Happiness. My rights are so basic that the founding fathers embodied them into the earliest documents written for this new country the united states of America.

Fraud is Foisted Upon Us

- 4. In 1777 the Articles of Confederation were written and ratified by all 13 Colonies. Then in 1787 the Constitution **For** the united states of America was created. Many of the colony delegates did not agree with this new constitution and in order to make it appear lawful and that it was unanimous, the framers signed it "Done in Convention, by the unanimous consent of the states present", but *not all states were present*. Seventy-four delegates were named, but only 55 attended and 39 signed. Of the 39, only 13 may have been in office replaced at the time of the signing. To be lawful, all 13 states and all delegates must sign. THUS FRAUD [began] was committed in.
- 5. A new corporate Constitution "of" the United States was written and ratified in 1788, which states that treaties are the supreme law of the land. Article VI

1790 The Corporation is Coming

6. On August 9, 1790; Article ONE of the U.S. Statutes at Large, pages 138-179, <u>abolished States of the Republic</u> and created federal Districts. In that same year the former States of the Republic [Colonies] reorganized as Corporations and their legislatures wrote new State Constitutions and brought forward corporate seals, absent defined boundaries, which they presented to the people of each State for a vote. [Remember your Jural Assembly and how you each voted to bring forth the original "intent" of that first written state constitution and seal. Our paperwork is the identical procedure of the founding framers to make certain our actions and documents are lawful.] The people were fraudulently made "Citizens of the United States".

1868 A Remedy

- 7. July 27, 1868 15 Statute at Large Chapter 249, Sec. 1 "Acts Concerning American Citizens in a Foreign State", the Expatriation Act; "That whenever it shall be made known to the President that any citizen of the United States has been unjustly deprived of his liberty by or under the authority of any foreign government...".
- 8. Minority Report No. 1956, 49th Cong. 2nd Sess, Feb. 25, 1887 and found in the 1938 Cong. Record Vol. 83 Pt. 1 Jan 27, 1938 (p. 1-1186) "The Court...holding that there were 2 citizenships in our system...and one of the state...that the rights, privileges and immunities of such a person as a citizen of the United States were separate and distinct from his rights, privileges and immunities as a citizen of a State;" "All rights are secured to citizens by treaties with foreign nations". [You have] "The right to become a citizen of a State by domiciling in it".

- 9. Codes, statutes, rules, regulations, and ordinances are enacted by the corporation, FOR the corporation Does NOT apply to the de jure state citizens.
 - 10. All legislation is a contract !!! A CORPORATE Contract !!!
 - 11. The Clearfield Doctrine states the necessity of a contract.
- 12. Erie Railroad Co. v. Thompkins, 304 U.S. 64 decision states that there must be a contract in order to give a remedy.
- 13. Rule 5 FRCP If the name on a document is NOT dishonored, you have a (contract) agreement.

1933 The Bad Boys

14. On December 26, 1933 --- congressional members passed 49 Statute 3097, Treaty Series 881, Convention of Rights and Duties of States, stating that **Congress replaced Statutes** with International law, placing all states under international law.

1945 Things Get Worse

- 15. December 9, 1945, Congress initiated the International Organization Immunities Act which in essence <u>relinquished every</u> <u>public office in the United States</u> to the United Nations.
- 16. 22 CFR 92.12 92.31 states that an oath is required to take office.

17. Title 8 USC 1481 states once an oath is taken, citizenship is relinquished, thus **that person becomes a foreign entity, agency or state**. This means every public office is a foreign state.

COMPLETE TAKEOVER

18. Title 22 USC Chapter 11 identifies <u>all</u> public officials as foreign agents.

The United States Corporation belongs to the United Nations

- 19. The IMF is an agency of the United Nations. Black's Law Dictionary 6th Ed. P. 816
- 20. The IRS is not a US government agency. It is an agency of the IMF Public Law 94-564, Senate report 94-1148 p. 5976.
- 21. The U.S. Treasury is now the IMF (Presidential Documents Vol. 24-No. 4 p. 113, 22 USC 285-2887)
- 22. The United States has NOT had a Treasury since 1921 (41 State. Ch 214 P. 654).
- 23. The United States does not have any employees because there is no longer a United Sates! (Executive Order 12803)

The United Nations is HERE!!!

- 24. Social Security Numbers are issued by the U.N. through the IMF. (20 CFR Chap. 111 Subpart B. 422.103 (b))
- 25. Social Security checks come directly from the IMF, which is an agency of the United Nations.

- 26. Social Security is not insurance or a contract. Nor is there a Trust Fund. (Helvering v. Davis 301 US 619 Steward Co. V. Davis 301 US 548)
- 27. The Corporation presumes that you are a corporation and acts accordingly. **PRESUMPTION**: if one does not rebut the presumption **in the beginning**, you are then considered a corporate entity. You have NO private standing. You have given up your private status.

One More Remedy

28. On October 4, 1982 Congress declared the Bible "The Word of God", Public Law 97-280, the 97th Congress, 96 Stat. 1211.

UNITED NATIONS OCCUPIED

It is court suicide to sue an officer of any corporation. Each as a foreign entity will take you into international (United Nations) law, where we have no standing.
